## Cm. Frank Haight -

- 1. Recommendation from Finance committee to approve the cost of \$5,900.00 to repave the Police Department parking lot out of the Police fund and the need to amend the 2018 Police Fund Appropriations, increasing \$5,900.00. The Solicitor will present the Ordinance for Council's consideration.
- 2. Recommendation from Finance committee to approve hiring a seasonal employee-general laborer @ \$10.00 per hour out of the appropriate funds the work is performed.
- 3. Recommendation from Finance committee to approve the first step for a \$720.00 yearly increase in each Council member's salary out of General Fund, a \$360.00 yearly increase in each BOPA member's salary out of Water/Sewer Fund and a \$1,000.00 yearly increase in the Mayor's salary out of General Fund. The Solicitor explained that when a term ends then the raise will go into effect. The raise does not go into effect if someone is appointed to finish a current term.
- 4. Recommendation from Finance committee to donate \$3,000.00 towards the purchase of the electronic sign that the Lion's Club is pursuing and expend it out of 2018 General Fund Capital Appropriations.
- 5. Recommendation from Finance committee to approve \$3,000.00 out of General Fund Capital Appropriations for make repairs to the Community parking lot.
- 6. Recommendation from Finance committee to approve \$2,500.00 out of Cemetery Fund to make repairs to the Cemetery middle driveway and to amend the 2018 Cemetery Appropriations, increasing \$2,500.00. The Solicitor will present the Ordinance for Council's consideration.
- 7. Recommendation from Finance committee to approve an increase in the 2018 tree line item Appropriations, increasing \$4,000.00. The Solicitor will present the Ordinance for Council's consideration.
