Citizens Presentations/Comments/Requests

1. Patty Murphy was present to voice her concern regarding her elderly neighbor Mary Taylor, who she feels is being taken advantage of by Eric Mino's daughter Mel. Mel has also been served eviction papers by Mr. Mino so she shouldn't even be around there. Patty is also concerned that Eric Mino was arrested at 5:30pm., May 30, 2019 and taken to Wayne County and then released by Wayne County. Officers responded to a call at Mr. Mino's home around 10:30pm. that same night. Patty is concerned about the number of officers at the scene at 109 Euclid Street that night and why was Mr. Mino released from Wayne County. Patty also called dispatch non-emergency number just to talk to an officer about this whole event. They put call to two (2) cruisers, but cruisers never showed up. Jim Adkins asked why the officers didn't go door to door.

Chief Meshew responded with the facts. The daughter of Mr. Mino was not served eviction papers. Mr. Mino was arrested for OVI, booked and released by Wayne County which I am not happy with. Backup was called for and Wayne County officers were responding to other calls and could not respond so Medina County responded as well as Seville. Shotguns were out, neighbors were not in danger. There was a verbalized threat by Mr. Mino, no weapons out. The only house notified was to direct north of Mr. Mino. When I arrived on the scene, I relieved Medina and Seville. All of this is protocol. When dispatch called in regards to Patty Murphy wanting to talk about the event, Officer Fockler was with a traffic stop. I did talk with Patty this morning about everything. I am trying to do everything I can to appease you Patty, I am not sure what else I can do.

Patty responded that she didn't want to be appeased, she just wants to be listened to and that she will just keep doing what she does, looking out for her neighborhood.

In regards to Mary Taylor, we can cruise that street 20 times a day but unless we get a call there is nothing we can do.
