3. Dale Shelly then asked who's responsible for the Boulevard coming into Crestview Allotment. Mr. Shelly suggested the village put a sidewalk down the middle of the Boulevard. Jason Flory advised Mr. Shelly that the village is not going to put a sidewalk down the middle of the Boulevard but if Mr. Shelly wants a sidewalk there and is willing to pay for the cost of it then I am sure we could do that.
