Water/Sewer Supt. Marcus Allen

1. Marcus reported about the sewer blockage on Maple Street. There is a need to televise the area for roots and it would cost \$1,200.00.

A motion was then made by Bp. Jeff Hostetler and 2nd. by Bm. Randy Watkins to approve televising Maple Street sewer line for root blockage for no more than \$1,200.00 out of Sewer Fund.

- 2. Pumps at Pine Street Lift Station are constantly getting plugged and we are constantly cleaning out. There is a need for a flight pump for improvement. The cost would be approx. \$5,500.00. A discussion was held. Marcus will get a set quote.
- 3. The water plant filters are 25 years old. They were installed in 1992. I have a man coming out next week to give us an estimate.

4. Pneumonia testing has changed and there is a four (4) hour on site NH-3 training to make sure I will do this new testing correctly. The cost is \$450.00.

A motion was then made by Bm. Randy Watkins and 2nd. by Bp. Jeff Hostetler to approve NH-3 training for Marcus for no more than \$450.00 out of Water Fund.
