- 7. Mayor Armentrout read the Arbor Day Proclamation and announced that Arbor Day in Creston will be celebrated Friday, April 28th. @ 11am. in the Park with a tree planting.
- 8. Mayor Armentrout advised Council that Personnel met to discuss a grants writer because we had received a resume from Gary Harris. Personnel decided to not pursue a grants writer because we already have Poggemeyer Design Group who will look for and help with grants writing. We need to let Poggemeyer's know what grants we are looking for.

Cp. Tom Phillips -

1. Insurance meeting will be April 26th. @ 2pm. and two possibly three companies will be present.

Cm. Thomas Delong -

1. We had a Park meeting and approved Norwayne Youth Baseball field use for their season. Pam Hostetler asked if they had requested Pav. #2 for concessions. Tom replied yes and that if the building is rented they will not use it that day. Pam requested games date schedule.

Cm. Frank Haight -

1. We had a Safety meeting and the Solicitor will present the Burbank Police Coverage Ordinance for approval.

Cm. Marlin Hostettler -

1. Tried to have a Community Center meeting but didn't have a quorum. Will reschedule.

Solicitor Allan Michelson -

- 1. The property at 122 Stebbins Street has been in foreclosure since 2014, there are broken windows, the house is in disrepair and the yard is a mess. I had requested that the property be moved to a tax foreclosure but the bank is involved so we cannot do a tax foreclosure.
- 2. The property at 116 Brooklyn was put up for sheriff sale and Chase Bank bought it back. Chase Bank is dodging my requests for contacting them. Most banks have a maintenance company that they use to keep these types of properties in zoning compliance. Since the bank bought it back they are responsible for upkeep so I will keep trying to make them get this property zoning compliant.
- 3. The Solicitor offered Resolution #17-8, a resolution stating that the Village of Creston opposes Municipal Tax provisions in the proposed 2017-2018 Budget, HB49. Ohio wants to collect business income tax now and then will continue until they collect all municipal income tax.

Cm. Tom Phillips stated the Park has deceased trees and the estimate to remove them is \$6,000.00. Mayor Armentrout advised Council that \$10,000.00 was approved in the 2017 Appropriations and that \$6,000.00 will need to come out of the \$10,000. Mayor Armentrout and Pam Hostetler reminded Council that these are the types of things that Pam asks for in October or November so they will be included in the next year's appropriations.
